**HABRAAC HAWLEEDKA XAAFIISYADA**

(INSTITUTIONAL PROCEEDURE)

- 1) Wasiirku waa maamulka ugu awooda sarreeya maamulka daryeelka xoolaha, wuxuuna mas'uul ka yahay guud ahaan siyaasadda dalka ee ku wajahan xanaanada xoolaha iyo hawlaha la xiriira.

**SARKAAL MADAXEEDKA DARYEELKA XOOLAHA**

(CHIEF VETERINARY OFFICER)

- 1) Hawlaha daryeelka xooluhu waxay hoos imanayaan xukunka/awoodda Sarkaal-Madaxeedka daryeelka xoolaha (Chief Veterinary Officer, CVO) kaas oo loola jeedo madaxa agaasinka caafimaadka xoolaha (Head of the Directorate of Animal Health) Wuxuuna warbixin u gudbiyaa oo hoos tagaa Agaasimaha Guud iyo Wasiirka Wasaaraddiisa (WXXBD)

**MAS'UULIDDA SARKAAL MADAXEEDKA DARYEELKA XOOLAHA**

(RESPONSIBILITIES OF CHIEF VETERINARY OFFICER)

- 1) Waajibaadka Sarkaal – Madaxeedka daryeelka xoolaha waxaa ka mid ah kuwa soo socda:
  - a) Soo jeedinta siyaasadda iyo istiraatiijiyadda dawladda ee ku wajahan caafimaadka xoolaha
  - b) Kala mudnaan siinta tallaabooyinka wax qabad ee ku qotoma natiijada ilaalinta (surveillance) xaaladda caafimaad ee hadba xooluhu ku sugan yihiin.
  - c) Qorshaynta iyo taabba gelinta barnamijyada kala duwan ee lagu horumarinayo xanaanada xoolaha.
  - d) Diyaarinta miisaaniyadda la xiriirta barnaamijyadasi
  - e) Maaraynta shaqaalaha, qalabka iyo imkaaniyaadka kale
  - f) Qiimaynta (Evaluation) Barnaamijyada/Mashaariicda iyada oo laga eegayo is barbar dhigga kharashka iyo dakhliga (Cost Benefit analysis)

- g) Sugitaanka iyo adkaynta iskaashiga lala leeyahay dalalka deriska ah, kuwa xiriirka ganacsi lala leeyahay iyo Hay'adaha caalamiga ah (International Organizations)
  - h) Dejinta/asaasidda qaab iskaashi iyo wax wada qabsi ee dhex mara Sektorrada qaabilsan adeegyada caafimaadka dadka iyo kan xoolaha,iyo waxyaabaha kale ee WXXBD (Xannaanada Xoolaha, Beeraha iyo Deegaanka)
  - i) Kontorolka/ilaalinta waraha xooluhu ka cabbaan oo ay ka dhalan karaan cudurrada dadka ku dhaca
  - j) Faafinta khabaarta iyo warbixinta ku saabsan cudurrada iyo xakamayntooda oo si loo baraarujiyo loona dardar geliyo dadwaynaha.
- 2) Sarkaal – Madaxeedka daryeelka caafimaadka xooluhu (CVO) wuxuu ka jawaabayaa mas'uulna ka yahay wixii ka yimaada ruqsadda caafimaad qabka xoolaha ee loo isticmaalo Ganacsiga caalamiga ah (The CVO is accountable for Veterinary Certification used for international Trade).

**AWOODDA NIDAAM-HOOSAAD / AWAAMIR DEJINTA**  
(POWER TO ISSUE INSTRUCTIONS)

- 1) Wasiirku isaga/iyada oo la tashanaya Agaasimaha Guud, Sarkaalka Madaxeedka Daryeelka Caafimaadka Xoolaha (CVO) iyo mas'uuliyiinta kale ee hawlaha khuseeyaan, wuxuu dejin karaa nidaam hoosaadyo, wareegtooyin iyo awaamir qoraal ah oo lagu sugayo habsami u taabbo gelinta qaanuunkan. Waxyaabaha ku qeexan qaanuunkan ka sokoow, Wasiirku waxa kale oo uu awood u leeyahay:
  - a) Maamulidda amase nidaaminta (Regulate) marka ay la gudboonaato ganacsiga caalamiga ah ee xoolaha amase nooc ka mid ah, amase waxyaalaha xoolaha ka soo baxa sida: Hilibka, Hargaha, Maqaarada, Dhogorta, Digada/Saalada, Minada, daawada talaalka, dhiigga (Sera) iyo waxyaabaha kiimikada ah amase biyoolojiga ah ee loo isticmaalo xakamaynta cudurradda xoolaha ee loo dirayo amase laga keenayo dal, deked amase carri kasta oo cayimman ee (To/From any specified country, Port or territory)
  - b) Soo saaridda amar Edeg-takoor (Karantiil) amase ku dabbaqid tallaabooyin cayiman ee baaritaan caafimaad ee lagu sameeyo ganacsiga caalamiga ah ee xoolaha.
  - c) Dejinta/dhisidda nidaam (hab-raac hawleed) rasmi ah oo dhakhaatiirta xoolaha dawladda u oggolaanaya inay baaritaan ku sameeyaan caafimaadka xoolaha iyo/amase caafimaadka guud (public health inspection) ee badeecooyinka, iyo inay bixiyaan shahaadada caafimaad qabka (Certification) marka ay munaasib tahay iyada oo la raacayo nidaamka ku qeexan xeerka caalamiga ah ee caafimaadka xoolaha (OIE Code)
  - d) Dejinta / soo saaridda hab-raac hawleed rasmi ah isaga oo la tashanaya guddiga daryeelka caafimaadka xoolaha kaas oo u oggolaanaya fulinteeda sektorka gaarka ah sida dhakhaatiirta- xoolaha ee madaxa banaan, sharikadaha amase ururrada. Xafiisyada xilalka rasmi ah (dawli)
  - e) Hab raac lagu kala sooco hadba xaaladda caafimaad ee aagagga kala duwan si cudurrada loo xakamayeyo oo loola socdo iyada oo la raacayo xeerka

- caalamiga ah ee OIE, iyo soo saarridda farriimo-hawleedyo/awaamir (instructions) hawl gal dheeri ah loo gelayo
- f) Dejinta wareegtooyin iyo hab raac hawleedyo ku saabsan cidda matalaysa (Liaison) iyo qaabka loola xiriirayo hay'adaha caalamiga ah (FAO, WHO, OIE, WTO, iwm) Shaybaarada iyo xarumaha cilmi baaris goboleedyada ee dawlga ah (KARI, ILRI, iwm), wadamada deriska ah iyo kuwa dalkeenu la leeyahay xiriir ganacsi
  - g) Go'aaminta heerka/ qiimaha laga qaadayo (ka dib markii uu la tashado guddiga daryeelka caafimaadka xoolaha iyo ciddii kale ee ay hawshaasi khuseeyaan ),
  - h) khidmada Adeegyada, khidmada macaamiishu bixiyaan iyo khidmado kale ee qaanun kani jideeyey in laga qaado ciddii hawl loo qabto
  - i) Dejinta habraac dawladeed rasmi ah iyo soo saaridda wareegtooyin ku saabsan maaraynta iyo isticmaalka daawada, talaallalka iyo wax yaabaha kale ee biyolojiya ah (Other biological materials). Ee xoolaha khuseeya
- 2) Ka dib markii uu wada tashi iyo is afgarad la yeesho xafiisyada/hay'adaha dawladda ee ay hawshu khusayso, Wasiirku xilaal-hawleedyo cayiman ee adeegyada caafimaadka xoolaha wuxuu u xilsaari karaa guddiyo, wakaalado amase hay'ado uu dusha ka ilaaliyo lana xisaabtamo maamulka daryeelka xoolahu.

### **GUDDIGA SARE EE DARYEELKA CAAFIMAADKA XOOLAHA** (THE VETERINARY BOARD)

1. Dawlad goboleedka Puntland waxay yeelanaysa guddi nidaamsan oo loo yaqaan: (Guddiga Daryeelka Caafimaadka Xoolaha ) sida ku qeexan qaanuunkan wuxuu:
  - a) Ahaanayaa mid ka madax bannaan oo uu aqoonsan yahay maamulka daryeelka xoolaha (Veterinary Administration)
  - b) Dejiya nidaamka diiwaan gelinta dhakhaatiirta xoolaha iyo aqoonyahaynnada kale sida (Farmashiste, Entomologist, Micro-biologist IWM), kaaliye caafimaad xoolaad iyo farsamo yaqaan shaybaar (Laboratory Technicians), Cunno Baare, rimay gacmeed sameeye, xirfadle tallaal sameeye iyo gargaare xoolaad
  - c) Diyaarinta dhaqan-asluubed wanaagsan iyo anshaxa shaqada oo lagu hanuuniyo ayna ku dhaqmaan aqoonyahannada iyo xirfadleyaasha ku xusan qodobkan faqraddiisa "b".
  - d) U heellanaanta hawl karnimo iyo hab-sami u fulinta hawlaha la xiriira caafimaadka xoolaha iyada oo lala kaashanayo maamulka daryeelka xoolaha., kooxaha Aqoonyahannada/Ururka dhakhaatiirta iyo Farsamo-yaqaannada daryeelka xoolaha. (Professional bodies, Association of Veterinary and Zoo-Technicians)
- Guddiga sare ee daryeelka xooluhu waxa kale ee uu u xilsaaran yahay dhisidda iyo nidaaminta Ururka Dhakhaatiirta iyo Farsam-yaqaannada daryeelka xoolaha ee Dawlad Goboleedka Puntland.

- 1) Awoodda diyaarinta iyo soo saarridda xeer hoosaadyo iyo nidaam dheeri ah oo khuseeya ganacsiga caalamiga ah (Import/Export) iyo sugidda caafimaadka xoolaha si loo dhawro shuruudaha ay nagu xiraan dalalka xoolaha DGPL loo dhoofiyo iyo sida ku qeexan xeerka OIE, waxaana iska leh Maamulada daryeelka

xoolaha iyaga oo la tashanaya guddiga sare ciddii ay arrintani khusayso siiba
